- If your noncustodial parent is married, you must supply information regarding their spouse.
- Please DO NOT submit any additional documentation (such as tax returns) with this worksheet.
- International applicants all financial figures must be converted into U.S. currency when completing this form.

Submission Deadlines

Submit all documentation together by the following applicable deadlines:

- Early Action November 17, 2024
- Early Decision November 17, 2024
- Regular Decision February 17, 2024
