Incident Description:	The behaviors included new team members being forced to attend an "initiation" event that involved wearing a uniform, performing training exercises, and consuming alcohol.
Outcome:	Responsible Finding. Sanctions included a 7-week suspension of activity, deferred suspension for 7 terms, individual reflection papers, and a team reflection. Two individuals were charged with hazing in this case, but allegations were withdrawn as the conduct process revealed that the incident was more organizational than individual.

Behaviors also included the use of racialized names. Additionally, two potential new members were hospitalized: one for drugs and one for alcohol.
Outcome:	The organization accepted responsibility for hazing violations. The organization was placed on a two-year suspension of recognition.
